Show Entry Conditions

- 1. Judging will be based on the competition rules laid down by the SGF Orchid Show, Show Schedule. Judges' decision will be final.
- 2. Shortlisted Landscape Exhibitors will be provided with the following materials:
 - Foliage plants including small trees, shrubs and ground cover
 - Saw dust/wood shaving/coco chips
 - Sand
 - Tree branches, (about 2-4m long & 10-20-cm diameter)
 - 4 x spotlights for 10 sqm and 6 x spotlights for 15 sqm
 - 2 x 13 amp power point for each landscape exhibit
 - A3 signboard to indicate name of Exhibitor and country
- 3. For requests of general construction of water features, please specify drawings and dimensions. We will try to assist in the construction/installation, subject to overall look and site restrictions.
- 4. No exhibits are to be removed before the dismantling of landscape display without the permission of the show manager.
- 5. While care will be taken to safeguard the exhibits, exhibits are displayed at the owners' risk. The show committee cannot accept responsibility for any damage or loss of any exhibit.
- 6. Watering / misting and maintenance of plant exhibits will be carried out by the show organisers. Exhibitors who wish to perform their own watering and maintenance schedule of their exhibit can make known to the Show Manager.
- 7. Landscapes should not contain flowering plants other than orchids.
- 8. Permission for vehicle access must be arranged with show secretariat during off peak hours. Vehicle are not allowed to park in the Gardens, strictly for loading/unloading of orchid plants near show site only (*Refer to Annex B for drive-in route*).

9. The Show Organisers may remove or replace plants or flowers in the landscape which are unable to last the full duration of the show. Exhibitors whose plants are removed from the display will be notified.

Terms and Conditions

- 1. The Judges' decision is final and conclusive. The Judges reserve the right not to award prizes if exhibits are not up to standard.
- 2. Whilst copyright in the design of the display remains with the Exhibitor, the Exhibitor grants to the Organisers the right to reproduce the display without the prior approval of the Exhibitor. However, in such an event, the Organisers will acknowledge the Exhibitor as the designer of the display.
- 3. The Organisers reserve the right to dispose of any item that is not removed from the competition ground after the end of the event and the Organisers shall not be liable to the Exhibitor for any loss, expenses, damages or any other consequences arising from such disposal.
- 4. Exhibitors are responsible for their personal belongings. The Organisers will not be responsible or liable for any injuries, lost, damaged or stolen items or any other losses resulting from participation in this competition.
- 5. The Organisers reserve the right to amend these terms and conditions without prior notice.





Important Note:

- All access will need to be cleared in advanced with the show secretariat
- Vehicle travelling in the Gardens should be escorted by a proxy on foot (in front of the vehicle)
- Vehicle hazard lights are to be turned on in the Gardens
- Vehicles are not permitted on lawns/grass patches. If considerable damage has been made to the lawn, reinstatement of turf is required.
- Work area shall be cordoned off with a set of safety cones, red-white / black-yellow tape
- No damage should be done to any tree, shrubs, flowers, plants and roots all these are protected by the parks and trees act and are liable to fines and reinstatement
